- This '**Advance Registration Fee (ARF)**' is ₹ 25,000 for JEE (Main + Advanced) & ₹ 20,000 for JEE (Main) & AIIMS/ NEET. This ARF amount is inclusive of all applicable taxes.
- The '**Advance Registration Fee (ARF)**' amount does not include Caution Money (Rs. 2000/-).
- For Students who are depositing the fees in 2 or more installments, it is mandatory for them to submit a Post Dated Cheque (PDC) for the installments at the time of depositing the 1st Installment.
- A student can avail additional fee benefits in course fee by depositing the One Year's Course Fee (First instalment, Full Fee) and/or Two Years' Course Fee (in Case of two year courses) on or before the prescribed dates (as per the schedule).
- A student appeared in ResoFAST and have taken admission in Resonance in YCCPs as stated earlier; shall not be allowed to appear in ResoNET [for JEE (Main + Advanced) / JEE (Main) / AIIMS/ NEET YCCPs] on the basis of same enrolment No. & his/her course fee shall not be transferred to any other course. If the student is still desirous to appear in ResoNET; he/she may do so by buying a new Admission Packet for ResoNET by paying requisite fee & applying for refund from the YCCP admitted through ResoFAST. The refund shall be granted only as per rules. In this case, scholarships & other benefits offered through ResoFAST will not remain applicable & will be withdrawn. If the student is desirous to appear in ResoNET [for JEE (Main + Advanced)/ JEE (Main) / AIIMS/ NEET YCCPs] he/she may do so by buying a new Admission Packet for Academic Session 2020-21 by paying requisite fee.
- The performance of a student in ResoFAST & ResoNET are independent & the performance linked scholarships of both the tests cannot be linked and are non-transferable.
- There will be no transfer of Course/Medium/Study Centre in case of admission through ResoFAST. If any transfer of Course/Medium/Study Centre is still required then it will be done by depositing requisite fee and in such case all the benefits availed through ResoFAST will stand void, the fee will be refunded as per Refund Rules and the student will have to take a fresh admission through ResoNET.
- The student will have to deposit the self attested photocopies of marksheet of IX, X, XI or XII class and competitive examinations (as applicable) within 15 days of declaration of Result.
- Decision regarding Scholarships, Fee Benefits, Due Dates of Fee Deposition, Course/Medium/Study Centre Transfer etc. are discretionary rights of Institute's Management.

You are supposed to bring the one of the ID proofs of the Card Holder at the time of swiping of card such as PAN card, Driving License, Voters card, or Aadhar Card.

### Important Information for Students (II-Installment Deposition)

For students depositing course fee of Resonance Yearlong Classroom Contact Programs (YCCPs) in installments i.e. I & II, have to deposit the II-Installment through Post Dated Cheques (PDC) at the time of admission i.e. deposition of I-Installment. The PDC is to be drawn in favour of "RESONANCE EDUVENTURES LIMITED". The PDC should be deposited in the envelope (Envelope for deposition of PDC) given in the Admission Packet. Please read the following cases properly:

**Note:** Students making lump sum deposition of course fee, no need of any PDC.

Students failing to deposit the amount of II-Installment in advance through PDC at the time of admission would be stopped from continuing in the regular classes after that particular date or would be given refund. The refund shall be applicable as per the standard refund policy of Resonance as mentioned in the ResoGuide.

### Important Note for Students & Parents

A student applied/appeared for ResoFAST for a particular date and declared successful (with/without scholarship); he/she will have to deposit the fee as per the date schedule attached to that particular ResoFAST Date only. A student shall not be allowed any flexibility in shifting/postponing the date of ResoFAST once he has applied or extending the fee deposition once he/she has been declared successful with/without scholarship.

A student's application for ResoFAST is date-bound. Once the date of ResoFAST & its related schedule is over; all benefits attached to this particular date of ResoFAST shall be ceased.

**For Class-XIII Courses:** If a student who takes admission in Resonance in any of the YCCPs offered through ResoFAST but later on declared by Class-XII board that he/she is not amongst the Top-20%ile of respective board or any other Class-XII Board % criteria for admission in IITs/NITs & AIIMS/Medical Colleges and decides to withdraw/course transfer from the course he/she has taken admission at Resonance; shall be given 'fee refund' as per following terms & conditions:

- The 'fee refund' application is submitted on or before 30th June, 2020.
- The 'fee refund' application is enclosed with attested photocopy of Class-XII board mark sheet. The original mark sheet shall also be seen for verification of photocopy).
- Copy of Official Document stating that he/she is not amongst the Top: 20%ile students of respective board.
- From the remaining course fee (Total Tuition Fee - Advance Registration Fee); the student will be deducted following flat Tuition Fee Amount (and applicable taxes):
  - ◆ For JEE (Main + Advanced) YCCPs: ₹ 25000 + Taxes
  - ◆ For JEE (Main) & Pre-Medical YCCPs: ₹ 20000 + Taxes
- A 'fee refund' application submitted after 30<sup>th</sup> June 2020 onwards shall be rejected for fee refund due to the above reasons and no 'fee refund' shall be applicable & given to the student under any circumstances.

### Note :

1. Number of weeks for the calculation of fee refund amount will be calculated from the date of commencement of regular classes (**Course/Batch**) (As mentioned in the academic calender) till the date on which refund of fee is applied for.
2. **The date of commencement of classes will be considered as mentioned in the Academic Calendar and not from the date on which the student joins the institute/ attends the classes or deposits the fee even if he/she is a latecomer to the institute.**
3. Refund amount shall be calculated on the standard course fee. ( As mentioned in the course fee structure).

**Process for Fee Refund:** If a student wants to leave the institute and opts for fee refund; he/she should follow the under mentioned steps:

- Collect the pre-formatted application of fee refund from institute's fee counter and fill it completely.



- Submit the filled-in refund application along with attachments (Original Fee Receipt(s), Original Identity Card and Study Material Coupons# at Institute's Fee Counter.
  - Collect the Acknowledgment Receipt of Refund Application duly signed & stamped by institute's authority and keep it for future reference.
  - **It is mandatory to submit a cancelled Cheque alongwith Application Form for fee refund.**
  - The fee refund transfer shall be done within 21 working days from the refund application.
  - If the student/parents face any problem in the process of course fee refund; the office of Manager-Operations/ Centre Manager can be approached personally/telephonically or through letter/e-mail/fax etc.
  - The student/parents should understand that fee refund is a part of institute's policy and we follow the refund rules & regulations as mentioned above in letter & spirit. However, if the request of refund is submitted (in written with required documents) after the 'refund dates' are over, the institute shall not entertain it. Moreover, refund requests made verbally/orally or through telephone/e-mail/fax shall also not be entertained.

## Cancellation of Admission

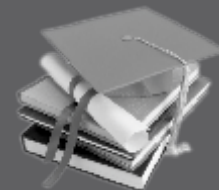
**The Institute reserves the right to cancel the admission of an enrolled students in Classroom Contact Programs (CCPs) in following cases:**

1. The student of a Classroom Contact Program (CCP) has failed to deposit the prescribed course fee after 04 weeks of last date of second/third/last Installment (as per option chosen) of course fee.
2. A student who is continuously absent for more than 02 weeks (12 working days) without any written information to the concerned authority. (at Kota: Head (Operations) & at Study Centre : Respective Centre Manager/Head).
3. A student who is showing frequent absenteeism (cumulative 30 working days) without any written information to the concerned authority. (at Kota: Head (Operations) & at Study Centre : Respective Centre Manager/Head).
4. A student who is absent for two consecutive tests without any written information to the concerned authority. (at Kota: Head (Operations) & at Study Centre : Respective Centre Manager/Head).
5. A student who is indulged in indisciplinary, unconstitutional, illegal activities.
6. Such a students whose enrollment has been cancelled due to one/any of the above reasons shall be called '**Dropout**' and his/her admission status shall be recorded as '**Admission Cancelled**' in the institute records.
7. A '**Dropout**' student can not claim any benefits/consideration/fee refund in future at any stage which otherwise are allowed/applicable to the enrolled students.
8. A '**Dropout**' student shall be conveyed his/her status of enrollment as '**Cancelled**' through an official letter by the institute.
9. Any objection/claim against the '**Cancellation of Admission**' can be reported to the concerned authority, as mentioned above, within 04 weeks of the issuance of the '**Letter of Cancellation of Admission**', only for reconsideration of admission.
10. Any objection/claim after 04 weeks of the issuance of the '**Letter of Cancellation of Admission**' shall not be accepted/entertained.
11. In case of any dispute the jurisdiction of Kota (Rajasthan) shall be applicable.
12. The cancelled admission will be considered as Fresh (New) Admission for the next session. In case of same session the student will have to pay a fine of ₹ 5000/- and the remaining fee to continue the classes.

7. In a Two-year Course, the scholarship provided shall be applicable for the first academic session (one year) only. The scholarship in the second academic session (i.e in the second year of the course) will only be provided on the basis of student's academic performance (% marks in periodic/cumulative tests conducted by the institute throughout the first academic session) and his/her overall conduct as perceived by the faculty & administration of the institute.
8. The student has to submit photocopy of an authentic document proving his/her eligibility to avail the disbursement of scholarship amount under GSP.
9. If a student receives any of the rewards as mentioned above during the course period & if he/she decides to leave the institute/withdraw from the course/shows continuous/frequent absenteeism before the completion of course at any stage; the institute will have all the rights to recover the reward amount/any other financial expenses incurred from the student. This may involve legal proceedings; if required.
10. A student eligible for the above scholarships Program may be denied or stripped off from the scholarship if his/her name is published/declared in public domain by any other institute/organization as a classroom/distance learning/e-learning student to take the credit of his/her selection as part of its promotional strategy. The institute will have all the rights to recover the Scholarship amount/any other financial expenses incurred from the student. This may involve legal proceedings; if required.
11. **Any scholarship is within discretionary power of Resonance & is not a matter of right for a student.** Resonance reserves the right to increase/decrease/remove scholarship categories mentioned above at any point of time & without explaining any reason. Decision of Managing Director of Resonance shall be final in this regard.
12. Any dispute will be subject to Kota Jurisdiction only.



## 10.2 Special Scholarship Program (SSP)

### 1. Objective:

The objective behind SSP is to reward, nurture and financially support the students who are having outstanding talent & intelligence required to succeed in JEE (Advanced). The financial support will be proficiently complimented by systematic classroom coaching for JEE (Advanced) at Resonance. The SSP shall equip the student to focus purely on JEE (Advanced) preparation by reduce, their financial burden by reimbursing his/her Pre-JEE (Advanced) (Schooling-Living-Coaching Expenses in Kota for a period of Max. 02 Years).

**Important:** Other students, who couldn't get it on the basis of their performance in ResoFAST/ ResoNET-2020, may still try for the remaining Head (3) of SSP on the basis of their academic performance in Periodic Tests conducted in Resonance during the whole academic session.

**Note:** Eligibility criterion for SSP to appear in ResoFAST/ ResoNET-2020.

### 2. Scholarship Structure/Major Heads:

The SSP aims at 100% substitution of academic and related expenses (Zero Cost) to be incurred by the student on his/her studies from Class-XI onward (till Securing Admission in IITs). This will include following 03 major scholarship heads:

- Head-01: Tuition Fee of Resonance for Yearlong Classroom Contact Programs (YCCPs) for JEE (Advanced) at Kota (\*Scholarship will be given based on ResoFAST/ NET or any other GSP)
- Head-02: School Fee of studying in any of the school in Kota.
- Head-03: Living Cost (Boarding & Lodging Expenses) in Kota.

### 3. Basic Eligibility Criteria:

- i) The student should be a permanent resident of India.
- ii) The student shall appear in ResoFAST/ ResoNET-2020 [Resonance National Entrance Test for admission in any of the Yearlong Classroom Contact Programs for preparation of JEE (Advanced)] for admission in academic session 2020-21. Also the student should be declared qualified for SSP in the result of ResoFAST/ ResoNET-2020; and an intimation of the same shall also be made officially on website to the student.
- iii) The student should study in any of the Yearlong Classroom Contact Programs (YCCPs) of Resonance at Kota for two academic sessions for the courses JA & JB (2020-21 & 2021-22).
- iv) The student shall study (schooling, coaching) at Resonance for a minimum period of two academic sessions for the courses JA & JB.
- v) For the student joining Resonance in Class-XI: The student should have secured Minimum 90% Marks (aggregate) or equivalent Grade and 95% Marks in Science & Maths or equivalent Grade in Class-X Board Examinations (CBSE/ICSE/any State Board or equivalent) in the Year 2019-2020.
- vi) All meritorious students under top-10 (declared in public/merit list in a reputed newspaper) of any National/State Board are eligible for SSP through ResoFAST/ ResoNET-2020.
- vii) All the three heads of SSP are applicable to the students coming to Kota City from outside. For the students of Kota City, all the heads except 03 will be applicable under SSP.

### 4. The details of 03 Major Heads of SSP are as under:

#### 10.2.1: Reimbursement of Tuition Fee as Scholarship for Tuition Fee

It shall be based on Performance in ResoFAST/ NET or any other GSP norms. The Scholarship details will be informed to the selected students after the declaration of Result of ResoFAST/ ResoNET-2020.

#### 10.2.2: School Fee of studying in any of the school in Kota:

- a) This is applicable only for the students of Class-XI.
- b) The Max. Amount to be reimbursed for School Fee shall be ₹ 25000/- (per annum) fixed or as actual, whichever is lower. Hence, the Maximum grant of scholarship for Two Years will be ₹ 50000/-.
- c) To avail this, the student has to show the school fee receipt in original and deposit its photocopy in the institute. He/She will be reimbursed for the fee deposited in the school at the end of the Academic Session.
- d) The grant of scholarship against School Fee shall be for a period of Max. two years (Two Years for the student taking admission in Resonance in Class-XI (Courses JA & JB).



- e) The above concession is valid only for One-Year i.e. academic session 2020-21. The Fee Concession in Second Year (For Class-XI students of Courses JA & JB only) will be based on their academic/disciplinary performance in Class-XI (Cumulative % in Resonance Periodic Tests & % Marks in School Examinations of Class-XI). This will be applicable according to following details:

- This is applicable to the students of Class-XI, Class-XII and Class-XIII.
- The Max. Limit of Reimbursement of Living Expenses is fixed @ ₹ 5000/- Per Month.
- This will include Room/Hostel Rent, Mess/Food Charges and Stationery & General Expenses.
- The grant of scholarship will be on monthly basis (on or before the 10th day of the month or finalization of test result whichever is later).
- Besides the academic performance, the reimbursement of Living Expenses shall also be subject to maintenance of minimum 90% attendance by the student in the institute in regular classes held during the previous month and appearance in all the previous month's periodic tests.

### 5. General Terms & Conditions for SSP:

- The award of SSP to a student is solely on the discretion of the institute.
- The institute may disallow SSP to an eligible candidate without assigning any reason.
- The complete range of SSP Heads is applicable for outstation students studying at Kota. The students who are residents of Kota are eligible for SSP only under Head 01 & 02.
- The institute reserves the right to revise/increase/decrease/stop number/amount of scholarships under SSP depending on institute's financial growth, success of the Program and enrollment of students in its various courses in the following years/academic sessions.
- In case of more than 50 students are found eligible for SSP during an academic session, the institute reserves the right to offer the SSP to best 50 students on merit grounds.
- The reserved category students shall also be considered for SSP with a performance relaxation of 10% in each slab of Major Head-1 as mentioned respectively and also be given the similar consideration (Max. 10% relaxation) in various eligibility norms wherever applicable.
- The student eligible for any scholarship under SSP shall not get himself / herself associated with any of competing institute/individual for any academic purpose in line with preparation for JEE (Advanced). If found, the student shall be immediately stripped off from SSP and any amount whatsoever is due under his/her name shall be stopped immediately. Moreover, in such a case the amount paid/given to him under SSP shall be repaid by the student to the institute else he/she will be suspended/terminated from Resonance.
- The student shall be disallowed from the benefits of SSP if his/her name is published/declared in public domain by any other institute/organization as part of their promotional strategy by taking the credit of his/her selection in JEE (Advanced) as a classroom/distance learning student.
- The student has to fill-up the Scholarship Application Form after enrolling in Resonance to get the benefits of scholarship under SSP.
- Institute's Operations Department at Kota shall manage the SSP. In case of any query; email at [admission@resonance.ac.in](mailto:admission@resonance.ac.in)
- In case of any ambiguity, clarity & understanding regarding the various provisions of SSP, the decision of institute's Management shall be final.
- In case of any dispute, the jurisdiction of Kota City (Rajasthan) shall apply.

**Note:** To avail any scholarship; the student has to fill-up the prescribed Scholarship Application Form available in the institute's office after enrolling in Resonance to get the benefits of scholarship under SSP. Further, the student has to submit photocopy of all the authentic documents proving his/her eligibility to avail the disbursement of scholarship amount under the relevant scholarship category.
