The students in Hindi medium will be similarly promoted to SANKALP (MPH). The students joining class 12<sup>th</sup> batches in February 2026 will be termed as MP. These students are likely to be benefitted in terms of more time for revision and getting prepared to tune with 12<sup>th</sup> syllabus. **Note:** For Students who are depositing the fees in 2 installments, it is mandatory for them to submit a Post Dated Cheque (PDC)/ JODO (resonance.jodo.in) for the 2nd installments at the time of depositing the 1st Installment.

The Rate of GST is decided by Govt. of India and is subject to revision. Hence, the rate/amount of GST may increase/decrease or any other tax may be introduced in the future. The Institute shall pass on the effect of change (increase/decrease/ intro of a new tax) in these rates to students/parents, if any change is announced by the Govt. of India. The students shall be informed at an appropriate time about the same as and when the Govt. of India announces the change.

## 3. Benefits of Joining MPA: Since 2013-14 session, we have been following the concept of forming early batches of class-XII students namely MPA. This has proved beneficial for our students. Some of the key benefits are as follow:

- 3.1 An early start helps to maintain less class frequency which results in a better understanding of the topics.
- 3.2 Early concepts of class XII get more time which results in an in-depth understanding of the key concepts.
- 3.3 Because of the early start, we will be able to complete Class-XII syllabus Boards & NEET (UG) by November 2026 and will get sufficient time for revision of Boards & NEET (UG) 2027.

## 4. How to Deposit Course Fee: The Course Fee shall be paid to Resonance Eduventures Limited:

- 4.1 Through a Demand Draft or Pay Order made in favour of RESONANCE EDUVENTURES LIMITED and payable at the respective Study Centre of Resonance where the student wishes to enroll for the course.
