

LETTER OF PROMOTION FROM CLASS-XI TO CLASS-XII

01st January 2018

Dear Parent,

Greetings from Resonance !

Your ward is going to complete course curriculum (Academic Session 2017-18) of 1st year i.e. Class-XI of Foundation Course at Resonance and will be promoted to Class-XII (VIJETA-JP Course) for the forthcoming Academic Session 2018-19. The students of VIPUL-JB Course will be promoted to the Course VIJETA-JP (the student of JB phase-VIPUL into VIJETA (JPB). For Hindi medium students batches shall be formed by merging the Hindi medium students of VIPUL-JBH Course as VIJETA-JPH.

The criteria for allotment of batches shall be as based upon final cumulative percentage (Including all PTs, CTs & MT) different tests will have different weightage in shuffling. In case, if a student has not appeared in the Major Test for genuine reason, then his/her performance shall be normalized to 100% by taking into consideration only the scores of CTs & PTs. The Last Date of Fee Deposition of I-Installment shall be considered as the second criterion in allotment of batches.

Important:

Students will be free from regular classes between 14-02-2018 till 01-04-2018 but there will be an arrangement of Doubt Classes & CBC for them.

Note: The students of Class-XI (JB) who will not deposit the course fee as per the schedule (I-Instalment); shall not be allowed to attend their classes in Class- XII: JP Course/batches. Also they will be imposed with Late Fee charges as per the rules of Resonance mentioned in ResoFAST Guide/ ResoGuide (2017-18) respectively.

Note: For Students who are depositing the fees in 2 or more installments, it is mandatory for them to submit a Post Dated Cheque (PDC) for the installments at the time of depositing the 1st Installment.

The Rate of GST are as decided by Govt. of India and are subject to revision. Hence, the rate/amount of GST may increase/ decrease or any other tax may be introduced in future. The Institute shall pass on the effect of change (increase/decrease/intro of new tax) in these rates to students/parents, if any change is announced by the Govt. of India. The students shall be informed at appropriate time about the same as and when the Govt. of India announces the change.

Note: To avail fee benefits offered through ResoFAST, one has to follow the above mentioned schedule of Course Fee deposition. If anyone fails to deposit the Full Course Fee as per the fee deposition date given over leaf then the fee benefits availed under ResoFAST will be cancelled and the student will be treated as one getting regular admission via ResoNET for JEE (Main + Advanced) course. In such case, the Complete Course Fee shall be charged as regular course fee for that academic session (applicable to all the students admitted through 'other than' ResoFAST) and not the concessional course fee offered under ResoFAST with fee benefits.

4. How to Deposit Course Fee: The Course Fee should be paid to Resonance Eduventures Limited by:

- Through a Demand Draft or Pay Order made in favour of "RESONANCE" and payable at the respective Study Centre of Resonance where the student wish to enroll for the course. The DD can be deposited in person at any of the Study Centers of Resonance. The student must write his/her Name, Father's Name, Course and Application Form No. on the Back of DD/ Pay order while depositing course fee. If the student is sending the DD through post then it should be sent to Kota office by Registered Post /Courier immediately so that it reaches us on or before the last date of fee deposition.
- The Fee can also be directly deposited in the **SBI Account of Resonance Eduventures Ltd. (30969014861)** / **CBI Account of Resonance Eduventures Ltd. (3154400127)** / **AXIS Bank Account of Resonance Eduventures Ltd. (911020066348406)** / **YES Bank Account of Resonance Eduventures Ltd. (039383900000185)(EASY PAY)** / **HDFC Bank Account of Resonance Eduventures Ltd. (50200016937462)** at any of the branches of Banks through Cash or Demand Draft made in favour of Resonance by using Fee Deposition Challan. The Bank Fee Deposition Challan is available at the Help Desk and can also be downloaded from the website www.resonance.ac.in.
- For Students who are depositing the fees in 2 or more installments, it is mandatory for them to submit a **NACH** (National Automated Clearing House) form or fill and submit the **DI** (Debit Instruction) form for the installments at the time of depositing the 1st Installment.

5. Resonance General Scholarship Program (GSP): For all the students of Resonance's Yearlong Classroom Contact Programs at Kota & other study Centres) Scholarships for students of VIPUL-JB Course, Resonance offers two categories of Scholarship as below:

1. Based on Cumulative Performance in the Periodic Tests (Cumulative Tests-CTs, Part Tests-PTs and Major Test (MT) at Resonance during the Academic Session 2017-18.
2. Based on Scholarship Test (JEE Syllabus of Class XI) after commencement of Class-XII VIJETA-JP Course on 22.04.2018 (Paper-I will be asked from their CT/ PT/ MT test paper held in class XI while Paper-2 will be unseen). This is to encourage students to revise topic of Class XI syllabus throughly with the help of revision plan mention in Point 2 as per their convenience).

Note:

1. All the Scholarship awardees shall be informed individually after finalization of Major Test (MT) result and/or Scholarship Test.
2. Performance in the Scholarship Test shall have appropriate weight-age in the first reshuffling of VIJETA-JP batch.

6. Change in Medium of Studies / Study Centres:

Institute has made a special provision for students who wish to change their Medium of Studies or Study Centre after fee deposition. The student has to fill up the Request Form (available at institute's counter) for change of Medium of Studies or Study Centre and deposit the requisite fee along with request form at institute's counter.



➤ For JA and JB phases two online practice tests (of 3 hours) will be held in the month of Dec 17 & Jan 18 for each student. One online practice test (of 6 hours) on JEE (Adv.) pattern will be held in the month of Apr/ May/ June 18 for each student.

➤ Free 2 full syllabus tests (of 6 hours duration) for classroom enrolled student of Resonance of JP, JF & JR who qualified for JEE (Advanced) 2018, in the month of April & May 2018 (before 20th May 2018).

➤ 20 additional full syllabus tests (of 6 hours duration) at nominal fee of Rs. 500 (to be submitted at Counter No. 9 & 10, Student Zone, CG Tower-1, Kota) for classroom enrolled students of Resonance are available from November 2017, each week test papers will be uploaded and students can attempt these tests at their convenience themselves on their own device.

➤ The students of JP, JF & JR Phases can login from the IDs they have been provided and will have access to all the test papers in online mode which he/ she has already given in offline mode and the test paper which he/she will be giving in remaining session in offline mode. He/she has to appear in these test papers in offline mode at pre-decided dates, later on he/she can practice these papers in online mode also.
